## ABOUT CAMPUS SEXUAL VIOLENCE AND TITLE IX OFFENSES

uSafeUS empowers campus community members with sexual violence prevention tools and response resources.

### 1 in 3

#### SURVIVORS OF CAMPUS SEXUAL ASSAULT NEVER FINISH COLLEGE

**One-third** of campus sexual assault survivors never finish college.

**Two-thirds** report negative impacts on academic goals.

#### COLLEGE WOMEN EXPERIENCE SEXUAL ASSAULT

**25.9%** of undergraduate women report nonconsensual penetration, sexual touching by force or inability to consent since entering college.

#### COLLEGE TGE STUDENTS EXPERIENCE SEXUAL ASSAULT

**22.8%** of transgender and/or gender expansive (TGE) students report non-consensual penetration, forced sexual touch, or inability to consent since entering college.

#### COLLEGE MEN EXPERIENCE SEXUAL ASSAULT

**6.8%** of undergraduate men report nonconsensual penetration, sexual touching by force or inability to consent since entering college.

### The Cost

#### OF SEXUAL ASSAULT LAWSUITS IS HIGH

**\$14.4 and \$9.4 million** are two recent publicly disclosed sexual assault lawsuit settlements by major universities. Many more are settled privately.
